A RESOLUTION TO FREEZE AND REDUCE SPENDING IN RESPONSE TO THE CO-VID 19 PANDEMIC AND UTILITY RATE INCREASES

At a meeting held on the 13th day of July, 2020, the following Resolution was presented to the City Council of Auburn:

RESOLUTION:

WHEREAS, the COVID -19 pandemic has caused economic turmoil which is expected to result in a reduction of tax revenues and other sources of revenues of the City of Auburn;

WHEREAS, the City of Auburn is incurring substantial expenses for water and sewer infrastructure repairs and improvements which are mandatory in nature and which have required that utility rate increases be borne by citizens of Auburn;

WHEREAS, in response to the above factors, the City Council has determined that the City should freeze and cut City expenditures as set forth below in this resolution.

IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUBURN, IOWA, THAT:

- 1. All mileage, meeting, and conference expenses for the Mayor, Council members, and employees are hereby frozen until such time as the City Council should decide otherwise by formal action. However, mileage incurred for banking purposes and mileage required for schooling of the City Clerk to maintain her financial and public works and sewer certificates shall be excepted from this resolution.
- 2. The City shall not enter any new memberships, excepting renewals of currently existing memberships.
- 3. The City shall not purchase any equipment or machinery, until such time as the City Council should decide otherwise by formal action.
- 4. The City shall not purchase supplies unless they are necessary.
- 5. The City Utility Clerk's hours shall be reduced.
