## RESOLUTION NO. 23-03

## A RESOLUTION AUTHORIZING AND DIRECTING TRANSFERS OF FUNDS

At a meeting held on the 13th day of February , 2023, the following Resolution was presented to the City Council of Auburn, Iowa:

## **RESOLUTION:**

**WHEREAS,** pursuant to Iowa Administrative Code Rule 545.2.5, transfers of moneys between funds found in the city budget forms must be approved by a fund transfer resolution;

WHEREAS, the City Council deems it beneficial to transfer Thirty Thousand Dollars (\$30,000.00) from the Local Option Sales Tax Fund to the General Fund for city hall repairs and equipment; and

WHEREAS, the City Council deems it beneficial to transfer Three Thousand Dollars (\$3,000.00) from the Local Option Sales Tax Fund to the General Fund for technology updates; and

WHEREAS, the City Council deems it beneficial to transfer Twenty-eight Thousand, One Hundred and Twenty Nine Dollars (\$28,129.00) from Capital Improvement Fund to the General Fund for a City Entrance Sign; and

WHEREAS, the City Council deems it beneficial to transfer Six Thousand Dollars (\$6,000.00) from the Local Option Sales Tax Fund to the Capital Improvement Fund;

IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUBURN, IOWA, THAT:

It is hereby authorized and directed that:

- 1. Thirty Thousand Dollars (\$30,000.00) be transferred from the Local Option Sales Tax Fund to the General Fund.
- 2. Three Thousand Dollars (\$3,000.00) be transferred from the Local Option Sales Tax Fund to the General Fund.
- 3. Twenty-eight Thousand, One Hundred and Twenty Nine Dollars (\$28,129.00) be transferred from Capital Improvement Fund to the General Fund.

4. Six Thousand Dollars (\$6,000.00) be transferred from the Local Option Sales Tax
Fund to the Capital Improvement Fund.
